2004 SECTOR PLAN AND SECTIONAL MAP AMENDMENT FOR THE PRINCE GEORGE'S COUNTY GATEWAY ARTS DISTRICT-MINOR AMENDMENT - (CR-017-2019)

The purpose of this public hearing is to give interested persons the opportunity to express their views concerning the proposed minor amendment to the 2004 Gateway Arts District D-D-O Zone (CR-017-2019), which will amend the Table of Permitted Uses for the Gateway Arts Development District to add a new use, "Urban Farm" as permitted uses within the Traditional Residential Neighborhood ("TRN") character area of the development district.
